Looking over the past year, there is something that really stands out for me. It's how many great volunteers we have devoting time to the Foundation. Between our three major events, the Walk for the Health of It, SummerFest and the Dr. Russell B. Steele Golf

Tournament, we have approximately 200 volunteers help get the events set-up and then support the running of them. This group is made up of our board members and spouses, Foundation scholarship recipients, high-school and college students and members of our community that are looking for ways to be of service. This is something really special about the people in Lodi, to give of their time, and I know we don't take it for granted. Without these folks, there would not be a lot of activity out of the Foundation. Thank you for your service.

Without the support of our generous, loyal donors, these things would not be possible.

I look forward to expanding the Foundation's reach in 2018 to include not only the hospital, but even more programs for the Lodi community and surrounding areas. This should be an exciting year.

Keeping mom & baby together



First Day Campaign Funds Level II NICU

Each year nearly 1,200 babies are delivered at Adventist Health-Lodi Memorial (AHLM), yet some 200 families, due to premature deliveries or complex conditions, cannot stay local for their birth. Worst yet, some babies born with life-threatening conditions must be transferred to a higher-level facility, separating the mom and baby, which prevents critical early maternal bonding. AHLM is committed to meeting the needs of our community and asked LMHF to create and manage a campaign to raise \$500,000 for equipment and training to open a Level II Neonatal Intensive Care Unit.

The First Day Campaign was launched in May 2017 with a booth at the annual Walk for the Health of It, where some of the specialized equipment was displayed and informational brochures were distributed along with cool sunglasses and teddy bears. Presentations were made to service clubs in the region, and, on Nov. 16, a fundraising event was held at Oak Farm Vineyards. Over 125 people attended the wine and appetizer event, and \$160,000 was raised, bringing the year-end total to over 72% of the \$500,000 goal. A \$100,000 grant application is pending, and we will complete the campaign in 2018.

Message from Our **CEO**



By many measures, 2017 was the best year for Lodi Memorial Hospital Foundation since its formation in 1980. The year saw numerous past donors and friends of the Foundation re-engage through renewed donations, attendance at events and sponsorships. All of

the events had increased attendance and higher net proceeds due to sponsorship growth, all of which lead to broader program funding. LMHF partnered with several organizations, including Leadership Lodi, Homeless Commission of Lodi, Hispanic Health Fair, Lodi Unified School District, GOT Kids Foundation, Community Foundation of San Joaquin and Adventist Health, to enhance the healthcare and healthy living within our community.

The First Day Capital Campaign to establish a Level II Neonatal Intensive Care Unit was launched in May, by year end reached nearly 75% of the \$500,000 goal, and will conclude in 2018. We received the \$1.4 million Boehmer Scholarship Endowment Fund, which enhanced our scholarship program for students and working professionals to continue their educational and career paths.

The Foundation also benefited from the addition of Liz Cochrane as our Donor Relations Manager, who will develop a more comprehensive donor communications program and steward relationships for the future. Motivated by our new mission and vision statements, the Foundation has broadened community involvement while continuing to support Adventist Health-Lodi Memorial.

Yes, 2017 was an exceptional year, which energizes us to do more in 2018. Thank you for your support, without which none of this would be possible.

Mission Expands for Foundation

After a comprehensive review in late 2016, the Lodi Memorial Hospital

Foundation Board of Directors adopted a new mission statement, broadening the mission and vision of the Foundation. The new mission statement reads:

its role and determined a refreshed mission statement was in order.

In support of the mission statement, the following vision statement was also developed:

“To support and promote healthcare; facilitate access to healthcare; advance healthy living; enhance public awareness of Lodi Memorial Hospital; fulfill our mission through philanthropic giving, events and donor relations.”

Foundation Board of Directors adopted a new mission statement, broadening the mission and vision of the Foundation. The new mission statement reads:

“Enhancing the Greater Lodi Community’s healthcare and healthy living through philanthropy.”

The new statement reveals an expanded view of the work of the Foundation. For over 35 years the Foundation has supported Lodi Memorial Hospital exclusively.

In 2015 and 2016, the Foundation began to support community-oriented needs related to healthcare, in association with the hospital, such as the Hispanic Health Fair and Cancer Kids of San Joaquin. Motivated in part by the vision of Adventist Health to serve the community, the Foundation assessed

In 2017 the Foundation began to implement these efforts by partnering with the Homeless Commission of Lodi to create a construction-skills training program in an effort to create “affordable-wage” jobs to provide for healthier living. LMHF also partnered with the Lodi Unified School District, Adventist Health-Lodi Memorial and GOT Kids Foundation (Giving Opportunities to Kids) in forming a school activity program to reduce obesity and diabetes in elementary school students.

Foundation and Partners FLIP with \$50,000 Grant

Obesity and diabetes are rapidly increasing and impacting the health of our nation. Did you know in the Heritage District of Lodi these rates are more than twice the state average? Some people believe these conditions are inherited; however, that is not the case. In fact, both conditions are the result of poor nutrition and sedentary lifestyles. In keeping with the expanded mission of LMHF to improve “healthy living” in the Greater Lodi Community, a partnership was formed with Adventist Health-Lodi Memorial (AHLM), GOT Kids Foundation and Lodi Unified School District (LUSD).

The partnership met to consider the most challenged population and develop a program to reverse this trend and improve lives. It was determined that working with elementary school children could create lifestyle decisions that would end this unhealthy cycle of poor diet and little exercise. Running an after-school program that included physical activities, nutrition education, health education and career education would offer an environment to learn and experience healthy

living lifestyles. The 12-week FLIP (Fit Life Impact Program) program will be offered at four Heritage District schools during the first year and will include over 100 students and likely 400 family members. Students will have professional physical trainers lead weekly exercise activities at their school, and nutrition education will be provided by dietitians from LUSD and AHLM as well as health education and career education at the hospital.



LMHF submitted a grant application for \$50,000 to fund the first year program, and full funding was received from the Community Foundation of San Joaquin from their Community Health Endowment Fund. The Community Health Endowment Fund was created by the Delta Blood Bank and supports health related causes within the county. The goal of FLIP is to expand to more schools each year.

Walk for the Health of It

In May, 120 volunteers erected 22 tents for the 27th annual Walk for the Health of It. We had a record-breaking 1,400 participants, ranging in age from one to over 90, all dressed in their bold black-and-red Walk t-shirts. Five elementary schools and four senior care facilities also participated.

DJ and board member, Marc Bregman, filled the air with music as everyone visited the photo booth, face painters, massage therapists and health fair. The largest tent housed 13 departments from Adventist Health-Lodi Memorial. Guests could check their blood pressure, glucose levels and receive valuable health information. Cross fit and Jazzercise (their 27th year) teams lead the crowd in a lively warm up session.

The large crowd of 5K walkers and runners pressed the starting line and were off at the sound of the horn to wind through the streets of wonderful homes

in Lodi's historic downtown. The one-mile course was filled with the kid's fun run, strollers and wheelchairs. The Tokay High School football team once again volunteered to push our seniors around the one-mile course for the Walk & Roll. They were joined by the wonderful residents of Hanot Care Facility and their staff.

The \$65,000 proceeds from the event were committed to the First Day Capital Campaign to develop a Level II Neonatal Intensive Care Unit at Adventist Health-Lodi Memorial.

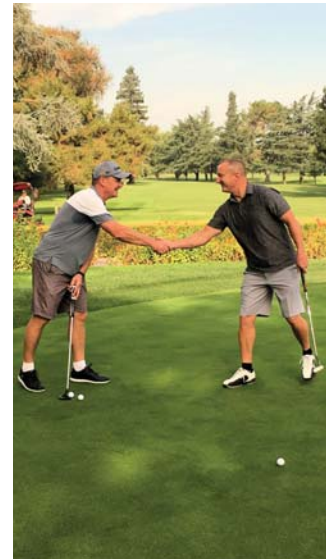

Scholarships Increase with **Boehmer Trust**

2017 was an exceptional year for the LMHF Scholarship Program, with over 80 applications from students with impressive resumes of academic achievement, school involvement, work experience, community volunteerism and determination.

Dr. Boehmer was a physician at Lodi Memorial in the 1950s-1970.

Welcome Elizabeth (Liz) Cochrane, who recently joined the LMHF staff in the new role of Donor Relations Manager.

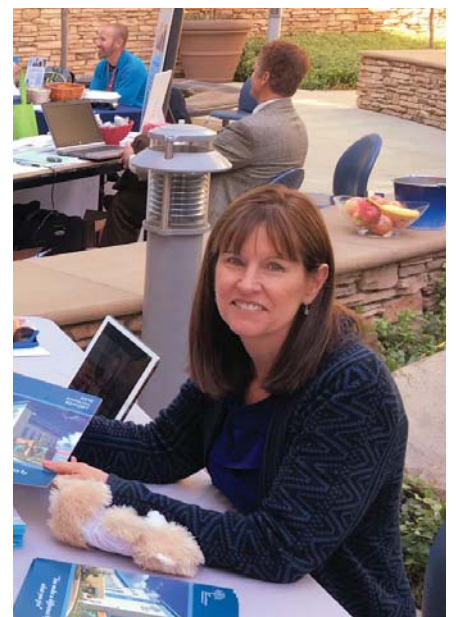

Leadership Lodi Project Unveiled

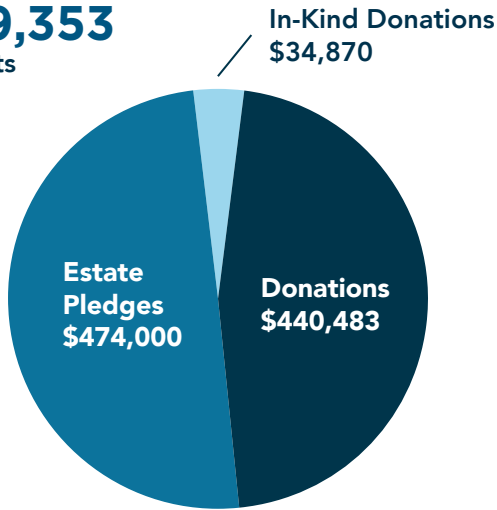
